DESCRIPTION _

The CB-12+ line of ceiling boxes has a smaller form factor and all the advanced features of FSR's "+" series ceiling boxes. The "+" series ceiling box is engineered for convenience and efficiency, featuring integrated threaded rod mounts for easy and secure installation. The new lockable cover latch ensures enhanced security and quick access when needed.

The **CB-12+** is a 1' x 2' enclosure that provides an external AC receptacle on the ceiling surface, five additional pre-wired AC receptacles inside the enclosure, one shelf to mount half-rack devices for AV equipment, and knockouts. A key improvement in the CB-12+ series is the consolidated fan & pre-wired AC arrangement, optimizing internal space for more flexible equipment management. All models come with two brush-lined low-voltage decorator-style wire entry plates on the chassis' sides to facilitate A/V and Data wiring requirements. An optional upgraded fan kit is available. A dual-tilting equipment shelf adds versatility for mounting & servicing equipment at a later date.

The **CB-12P+** is a 1' x 2' enclosure with the addition of an industry-standard 1½" NPT fitting to hang up to a 50 lbs. projector (including mount) while also supporting a maximum load 40 lbs. on the shelf. Pole mount units include decorative pole rail cover plates, and a solid door is available on all models to eliminate the need to cut ceiling tiles. This female pipe fitting may be mounted in any of 3 predetermined positions and trimmed with the included hole plugs.

SG-120HW - Type 1 Surge Protective Device

The optional SG-120HW is a UL Listed 1449 "Type 1 Surge Protective Device" used to protect branch circuits against damage from electrical transients occurring on the AC line. It provides protection against transients in all 3 modes: Line to Line, Line to Neutral, and Neutral to Ground. A diagnostic LED indicates ground presence, system power and that surge protection is active. (See ordering table)

MOUNTING KIT OPTIONS (for all models)

The CB-MNT1 cable mounting kit attaches to the four integrated threaded rod mounting tabs on the ceiling box exterior. The kit includes four 100" stainless steel cables and four Kwik-Loc cable adjusters.






